

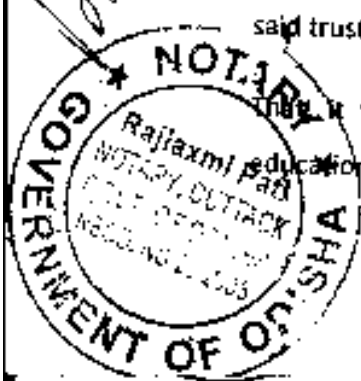

9. That, without affiliation /NOC, the school will not open/start classes IX/XI otherwise liable for suitable action as PER clause 15.9 OF BYE-LAWS OF THE BOARD.
